## RESOLUTION OF THE BOARD OF EDUCATION SCHOOL DISTRICT OF HACKENSACK

### D6 Approve Shared Services Agreement - Fuel

**Whereas**, the Hackensack Board of Education purchases gasoline and diesel fuel (collectively "Fuel") for its vehicles; and

**Whereas**, Bergen County operates fuel pumps for fueling of County vehicles; and

**Whereas**, the County fuel pumps are operated using hardware and software permitting the tracking and billing of multiple users; and

**Whereas**, the Board of Education wishes to enter into an agreement with County whereby County would permit the Board of Education to purchase fuel for its vehicles from the County fuel pumps; and

**Whereas**, the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1 et seq.) promotes the broad use of shared services as a technique to reduce local expenses funded by property tax payers; and


**Whereas**, the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1 et seq.) allows for any local unit to enter into an agreement with any other local unit or units to provide or receive any services that each local participating in the Agreement is empowered to provide or receive within its own jurisdiction, as set forth in N.J.S.A. 40A:65-7(4); and


**Whereas**, pursuant to N.J.S.A. 40A:65-5, the County and Board of Education have each adopted resolutions authorizing entry into this Agreement; now

**Be It Resolved**, in consideration of the promises and of the covenants, terms, and conditions hereinafter set forth, County and Board of Education agree to perform in accordance with the provisions, terms and conditions set forth in this Shared Services Agreement.
