BERGEN COUNTY BOARD OF CHOSEN FREEHOLDERS

RESOLUTION

WHEREAS, the Borough of Emerson ("Municipality") has need to use a grass area in front

of the Soldier Hill Golf Course located at 99 Palisade Avenue, Emerson, New Jersey 07630, for its

recreational soccer program practice; and

WHEREAS, the County of Bergen ("County") currently owns and operates the Soldier Hill

Golf Course; and

WHEREAS, the Municipality wishes to enter into an agreement with the County whereby the

County would permit the Municipality to use the grass area in front of the Soldier Hill Golf Course for

its recreational soccer program practice; and

WHEREAS, County Counsel has prepared a Grass Area Use Agreement ("Agreement") to

permit the Municipality to utilize the grass area in front of the Soldier Hill Golf Course for its

recreational soccer program practice to be held during a time and duration defined in the Agreement, a

copy of which is annexed to this Resolution; and

WHEREAS, the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1 et

seq.) allows for any local unit to enter into an agreement with any other local unit or units to provide or

receive any services that each local participating in the Agreement is empowered to provide or receive

within its own jurisdiction, as set forth in N.J.S.A. 40A:65-7(4); and

NOW THEREFORE, BE IT RESOLVED, upon the recommendation of the County Executive, that the County of Bergen enter into an agreement with the Borough of Emerson, permitting the Municipality to use the grass area in front of the County-owned Soldier Hill Golf Course for its recreational soccer program practice.

BE IT FURTHER RESOLVED, that the County Executive or his designee be and is hereby authorized to execute the attached agreement and any other related documents necessary to effectuate the intent and purpose of the contract in a form to be approved by County Counsel.
