**WHEREAS,** it has been determined by Anthony Cureton, Sheriff and Vincent Quatrone, Executive Undersheriff, that the need exists for the purchase of computer and UPS System equipment, required by the Agency; and,

**NOW, THEREFORE BE IT RESOLVED,** that Gerald T. Reiner Jr., CCPO, QPA, Purchasing Agent be authorized to issue a purchase order to:

CDWG INC., 2 CORPORATE DRIVE, SHELTON, CT 06484, TO FURNISH AND PROVIDE COMPUTER EQUIPMENT AND UPS SYSTEM EQUIPMENT, REQUIRED BY THE BERGEN COUNTY SHERIFF'S OFFICE, TWO BERGEN COUNTY PLAZA, HACKENSACK, NJ 07601, for a total value not to exceed \$82,000.00, to be charged to various accounts.
